You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid office at North Seattle College, as soon as possible so your financial aid will not be delayed.

#### Dependent Students

2. IRS confirmation letter dated on or after October 1, 2016 certifying that no 2015 tax form was filed or was required to be filed.
3. Copies of W-2 Form(s) from each employer in 2015.

**D. Parent(s) Income Verification (if Dependent student):**
